Notice is hereby given that Union County Government is seeking bids for the construction of a proposed Pathway Project within State Route 180, just north of Vogel State Park.

Bids may be mailed or personally delivered to the Union County Commissioner's Office at 65 Courthouse Street, Suite 1, Blairsville, GA 30512.

Bids must be submitted in sealed envelopes. Sealed envelopes shall be marked in the upper left-hand corner as follows:

Bids will be opened at 3:30 p.m. on Thursday, September 7, 2017 in the Union County Courthouse in the Commissioner's Office conference room. No bids will be received after the announced time of opening. Any bids received late will be returned unopened.

A Pre-bid meeting is scheduled for 2:00 p.m. on Thursday, August 17, 2017 at the Byron Herbert Reece Heritage Center, located at 8552 Gainesville Hwy, Blairsville, GA 30512.

Contractors will furnish all materials, labor, equipment, and all other things necessary for completion of the proposed project. The extent and character of the work to be done generally consists of the following:

Construction of approximately 0.23-mile of sidewalk pathway within State Route 180 connecting the Byron Herbert Reece Connector Trail with the Lake Loop Trail at Vogel State Park. Pathway construction will include the following: site demolition, grading, sidewalks, retaining walls, safety guardrails, pedestrian cross-walk striping and signage, handrails, erosion control measures, etc.

The above description in no way describes the full extent of all the work to be done. Only the major portions of the Project have been described.

The entire project must be completed within 120 calendar days after notice to proceed is issued.

Bidders on this project must be on the Georgia Department of Transportation Pre-qualified List of Contractors. All bids must include the following information: project references of at least three (3) similar projects within the last five (5) years.
