- Page 6 of RFP explains this pricing proposal and qualifications proposal. There is no proposal sheet. Submit your pricing proposal in your chosen format. The price proposal will be evaluated based on the cost as well as how thorough and comprehensive the proposal is submitted.
- The plans (Appendix D) are not bid level documents. These are basically the plans from a pavilion that was built years ago just past the Byron Herbert Reece Farm and Heritage Center on Hwy 129 South in Blairsville. The original architect did not do the plans in CAD therefore they could not be modified to be specific to this site. There's just one change from the original pavilion, and it is sketched out in the plans. Basically, you will submit a proposal to us to do that same pavilion, but on site at Meeks Park in Blairsville and this is not a big budget project.
- Septic, permanent power, and water will all be provided by the County to the site. All temporary utilities are the responsibility of the Contractor. Union County will handle all permitting.
- Keep in mind this is not a hard bid. Qualifications and relevant experience will be scored, but the price proposal will be a part of the scoring as well. Please be articulate in your price proposal.
- Timeline: we can award in the Union County meeting on November 15, 2018 and work could begin in December. We would like the project to be complete by Spring 2019.
- Potential offerors are encouraged to evaluate the existing the pavilion at the Byron Herbert Reece and Heritage Center on Hwy 129 South.
- All contract documents are on the County's website.
- 5% bid bond is due with proposals. Performance and payment bonds will be required to contractor who is awarded the project.
