
Resolution R-2021-15

WHEREAS, the Sole Commissioner of Union County has studied and revised the proposed budget, and it is considered in the best interest of Union County to adopt said budget.


THEREFORE, BE IT RESOLVED that the budget attached hereto for the fiscal year beginning January 1, 2022, and ending December 31, 2022, is approved.
