8. Agreement
Agreement between the Georgia Department of Corrections and Union County for six work details for the period of July 1, 2022 through June 30, 2023. The cost for these details is \$49,318.00 per detail totaling \$295,908.00 for the term of this agreement.
9. Agreement
Agreement between Legacy Link and Union County for the required local share during FY-2023 in the amount of \$105,000. This is the amount Union County has committed in local funds to operate the Senior Center from July 1, 2022 through June 30, 2023.
10. Amendment
Amendment 1 to the Intergovernmental Agreement dated March 29, 2021, between the Georgia Department of Natural Resources and Union County for the construction of a target shooting range located approximately nine miles southeast of Blairsville on Highway 180. This amendment had an effective date of March 8, 2022 and increases the amount committed by Georgia DNR from \$1,800,000 to \$3,420,000. This amendment also decreases the amount Union County agrees to contribute from \$600,000 to \$380,000.
