Georgia Weapons Carry License Application Information Sheet

THIS APPLICATION MUST BE COMPLETED IN ITS ENTIRETY BEFORE COMING IN THE OFFICE (EXCEPT FOR SIGNATURES)

- **Times for Accepting Applications:** Weapons Carry License Applications are accepted ONLY between the hours of 8:00AM to 4:00PM (closed for lunch from 12:30-1:00PM), Monday through Friday.
 - **Domicile:** Georgia law requires all applicants for a WCL to be domiciled in the county of application. "Domiciled" means the applicant lives in this county and intends to remain here. You will be required to present your Georgia driver's license or photo identification at the time of application. It must reflect your current Union County residential address; however, if you have a post office box, you must provide proof of your residential address (ie: homestead exemption, voters registration, tax records, etc.)
 - **Fees:** New licenses are \$78.25 (effective 8/1/2020). Renewal licenses (90 days prior up to 30 days after expiration only) are \$30.00. Payment is due at the time of application. Cash, local checks, and credit cards (charges a 4.5% processing fee) are accepted.
 - **Fingerprinting:** If you are required to be fingerprinted, you will be directed to the Union County Jail upon applying.
 - **Photograph:** All applicants are required to be photographed as part of the licensing process. This photograph will be made at the time of application.
 - **Eligibility:** This office will not "pre-qualify" you for a license. Any decisions on eligibility are made after an application has been submitted and a criminal history has been received. If you have questions regarding your eligibility, it is recommended that you seek the advice of an attorney. If there are problems with your eligibility after the application has been submitted, you will be notified.
 - **Replacements:** Replacements licenses are \$6.00. If your license is damaged, you must turn it in at the time of receiving the replacement. If your license is lost or stolen, you must report it to this office within 48 hours.
 - **Legal advice:** This office is not able to provide you with legal advice regarding where you can carry your weapon.
 - **Reciprocity*:** The following states honor Weapons Carry Licenses issued by Georgia: Alabama, Alaska, Arkansas, Arizona, Colorado, Florida, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Michigan, Mississippi, Missouri, Montana, New Hampshire, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, Wisconsin, and Wyoming. (***This list may be subject to change at any time pursuant to the state Attorney General's office. It is your responsibility to know the laws of these states.**)
