1. Proclamation  
Constitution Week, September 17 - 23, 2022 with Constitution Day being Saturday, September 17, 2022.
2. Adoption  
Adoption of a Moratorium on Crypto Currency and Bitcoin Mining Sites or Data Centers
3. Agreement  
Agreement between Union County and the Georgia Association of Conservation Districts, Incorporated in the amount of \$95,200. This Agreement is effective from October 1, 2022 to September 30, 2024.
