An affidavit swearing that the following appointment to the Election Board was made in compliance with HB 798 and the following person was appointed to serve on the Union County Board of Elections: George Burch (appointed by the Union County Republican Party to complete the term of John Strickland)
3. Agreement
Agreement letter between Union County and Legacy Link for the required local share during FY-2018 in the amount of \$10,450. These funds are used by the Area Agency on Aging as match to draw down federal and state monies for administration, coordination, information and referral, employment, and training of older workers and volunteer programs.
